### **Constitution of the Quinte West Chamber of Commerce states in section 33**

- a President, Vice-President and Secretary, all of whom shall be elected from amongst the Members by the Members by Ordinary Resolution at the First Quarterly Meeting of the Members in each year; and
- eight (8) Directors, all of whom shall be elected from amongst the Members by the Members by Ordinary Resolution at the First Quarterly Meeting of the Members in each year.

*As outlined under the Federal Board of Trade Act the Quinte West Chamber of Commerce directors serve a one-year term.*

**The Nomination Committee will put together the 2022 board slate looking for representation from businesses of all sizes and sectors. The slate will be approved and elected by the membership in January 2022.**
